Previous Actions completed

- **SAGL Training of Coaches (YPS)** – Took place 5&6 December 2015 @ Wilmcote Club. Many thanks to Trevor Haynes, NSRA Trainer, formal certificates are on there way.
- LDC members to distribute SAGL “come and have a go” flyers as discussed.
- Getting our league fully exposed on social media on a regular and continual basis? (Steve Ray coming up with some proposals and then working with ADS Smith to make it happen).
 - 29.09.2015 - Waiting information from Steve Ray and his social media experts as to what we do and how we do it.
 - Steve provided this information at the November delegates meeting for use to progress further.
 - Paul / Andy C to ascertain availability of Wilmcote club and cost of hire – 15.12.2015 sorted.
 - RG to obtain a sample of NSRA target card from Henley ARAPC and give to Steve Ray to establish if he can source this quality of card and then print up the NHAGL format on them.
 - 15.12.2015 - We have not received any feedback from Steve Ray on paper target card available. However, from other sources it is clear that the NSRA have full control on the card type.

- **Competition Organisers** - Create and publish a set of agreed competition rules, inclusive of measuring technique, covering home and away matches against the Redditch League and the paper target triple 6.
 - 14.04.2015. Nothing to report at this time. It would appear that common ground needs to be found on a number of issues, before bad feeling, between teams and indeed shooters, makes it not possible to compete in the future.
 - 14.04.2015 – No progress made/reported – **this requires actioning ASAP**
 - 29.09.2015 – No progress made although ADSS reported that the Redditch league was apparently not in such a bad position as first thought so it may well worth while revisiting this and trying to get some form of agreement with them.
 - 15.12.2012 – No further progress reported from Will Cémis.
- Derek Powers continuing with making 3 plates and plungers for testing at Wilmcote, Avon and Binton.
 - 15.12.2012 – No further action to report from Derek.
- **SAGL OPEN Actions**
 - RG to ascertain the hire cost of Henley shooting range for a day.
 - We need to call on the expertise of Paul Lowe and others who have experience of running such an event and see if they will buy in to a co- promotion – not sure who?
 - Purchase official NSRA targets and gauges.
 - 15.12.2015 – KEEP ON FILE HERE UNTIL WE HAVE PROGRESSED AND TRIALED THE INTERNAL SHOOT.

SAGL Paper Target Challenge (The SPTC)

- **Venue** - To be held at Wilmcote Social Club on Saturday 19 March 2016. Andy C to now firm up date with WSC. Following years will be shot on a Thursday evening.
- **Set up Range** - from 7pm – Start shooting at 7.30 till 11pm
- **Paper Targets** - North Hereford air Gun League (NHAGL) Target format, printed on the paper we use at the moment, with all 8 shots to count. Each entry will shoot 2 cards, one shot per target – (16 shots). Competition cards will be pre numbered and will not have any names on them. Only the Comp Administrator will know which cards belong to which shooter as this will be logged during registration.
- **Sighters** – To be shot on a different card specifically for Sighters.
 - Each sighting card can be used for 8 shooters.
- **Layout** - The target set up will be 4 targets on Grahams Gantry across the stage.
- **Firing Points** – Will be numbered 1 to 4. Each firing point will have a laminated target layout to assist shooters in ensuring they shoot at the correct target on the card and not double up. Andy C to provide the laminated firing point target cards. There will be a chair behind each firing point.
- **Distance** – 6 yards.
- **Time Limits;**
 - Sighters – 3 minutes Max
 - Cards – 8 minutes per card
- **Shooter Classification** will be undertaken by Andy Smith (AKA Stato) using Baildham Averages up to the end of Feb. Classifications will be published at the March Delegates meeting. The classification “cut offs” will be displayed by Andy Smith on the Baildham ladder.
- **Classification of Shooters;**
 - **Class A** – 33 to 35
 - **Class B** – 31 to 32.9
 - **Class C** – All others up to 30.9

(This may need to be adjusted annually)

- **Qualification for entry** – 2 matches completed.
- **Registration fee** - £2.00 per entry.
- **Ranger Officer Control** – The competition will be under the control of a Range Officer.
 - Working with the Ranger Officer will be a number of Assistants who will;
 - Change Targets
 - Take competition targets to the judges for scoring.
 - Take the scores from the Judges to Admin for display on a Black Board.
- **Judges** – There will be 3, in a separate room – **Their adjudication will be final. Competition cards will remain in the Judges room – Judges will not know whose cards they are scoring.**
- **Gauges used for judging** – Will be those provided by Paul Clingan.
- **Range Officer Commands** (just an example – Andy C to fine tune prior to Laminating Prompt Card)
 - Call shooters forward to the Range
 - Ask shooters to place guns in a safe condition on the firing table and sit down in the chairs
 - Explain detail of the shoot – Is everyone clear.
 - Call shooters to the firing point.
 - Shooters – Ready to shoot
 - Commence Sighting shots
 - When 3 minutes has elapsed or shooters have clearly finished sighter shots – Stop shooting.
 - Place guns on the table in a safe condition and sit down in chairs – RO inspects guns
 - Assistants please change the targets.
 - Repeat the above for each competition card
 - Assistants take competition cards to Judges and display Sighter targets
 - Shooters leave the range and safely case your guns.
 - Repeat.
- **In the event of a DRAW;**
 - 1ST – take the two centre diagrams on each card and add them up for each shooter highest score wins.
 - 2nd Again using the four centre diagrams for each shooter – closest to the bull wins.
- **Miss shot cards** – there should only be one hole per target diagram.
 - If you double up on a diagram – DONOT shoot the next one – leave it blank.
 - If 9 holes are on the Card then the Card is VOID.
- **Prizes** – Class Winners A, B, C & A Highest Score
 - Prizes presented at the SAGL Presentation Night.
- Andy C to produce rules etc from these minutes
- Andy Smith to put “SPTC stuff” on web sight and face book
- Andy C to produce flyer to team Captains to introduce SPTC to their members in an attempt to get them to take part.

This competition will be used to iron out and test what we need to have in place for a SAGL Open shoot.

3. **Documentation** – Nothing discussed.
4. **Social/ new shooter generator event** – Keep this on.
